



Purpose:

The purpose of this scholarship is to subsidize the attendance of two Library and Information Studies students to the biennial CARL conference and to subsidize the attendance of one Library and Information Studies student to the biennial ACRL conference, thus encouraging and supporting library school students in preparing for a career in academic librarianship.

Eliaibility:

Any applicant who has applied for admission to a formal program of library and information studies leading to a master's degree, and has enrolled in at least 6 credit hours (or its equivalent) towards his/her degree. Applicants can be either full-time or part-time students. Membership in CARL is required before or at the time of application.

Award:

The award for the CARL Conference is \$500 per student. The award for the ACRL Conference is \$1000. Conference scholarship funding is intended for the costs of registration, room and transportation. Note: The award may not cover all expenses depending on the conference location.

- * Two Letters of Reference
- * Resume or Vita that outlines related work experience, professional activities, and honors
- * Personal Statement a statement of a maximum of 350 words, double-spaced, typed and a font no smaller than 11 point, that outlines your interest in academic librarianship, speaks to the other criteria below, and addresses how your attendance at this conference will support your goals related to academic librarianship.

Criteria:

Factors considered in awarding the scholarship(s) include evidence of:

- * a commitment to a career in academic librarianship
- * a commitment to academics
- * proven leadership potential
- * financial need
- * strong communication skills
- * excellent organizational skills

Achievement in these areas may best be demonstrated by the personal statement indicating interest or work experience in an academic library, including class work, non-course educational experience, volunteer work, teaching or other relevant employment and publications. Candidates should also indicate what specific competencies or characteristics they believe they have to offer the field of librarianship, what they can bring to the profession, and in particular what they have done to demonstrate proven leadership potential and strong organizational skills. The criteria can also be demonstrated through the two professional references or vita.

A completed packet is everything listed under Application. Late or incomplete packets will not be considered.

Mashup the Library! Highlights from the CARL IT Interest Group Workshop

The theme for the 4th Annual CARL Information Technology Interest Group Workshop, held on July 25, 2008, was Mashup the Library. This workshop focused on exploring technology trends that have us remixing library and information resources in new and exciting ways. Drawing over 70 attendees from around the Bay Area, the day offered a full spectrum of speakers and demonstrations, and even a tour of the newly opened and innovative Harrington Learning Commons, Sobrato Technology Center and Orradre Library at Santa Clara University. This year's workshop was held in their very elegant St. Clare Room.

First up was Rachel Smith, Vice President of NMC Services for the New Media Consortium, who directs the creation of the annual Horizon Report (a collaborative project of the NMC and the EDUCAUSE Learning Initiative). The Horizon Report identifies and describes emerging technologies that are likely to have a large impact on teaching and learning that goes on in higher education. Attendees enjoyed her approachable and energizing introduction to the six emerging technologies that have been identified in the 2008 edition of the report. Using a VUVOX collage, rather than traditional Microsoft PowerPoint, Rachel walked through this year's forecast which included descriptions and applications of Grassroots Video , Collaborative Web, Data Mashups, Collected Intelligence, and Social Operating Systems.

Rachel also described the process for distilling the viewpoints of over 175 international members of the Horizon Report advisory board . There are no face-to-face meetings, all work is done online and documented on http://horizon.nmc.org/wiki. Next, Dr. Raymond Yee, a visiting scholar at UC Berkeley's School of Information where he teaches the course "Mixing and Remixing Information" and author of *Pro Web 2.0 Mashups: Remixing Data and Web Services* (Apress, 2008), focused attendees on what mashup technology is and how it works. Using examples from Google Maps and the Craigslist website, Raymond demonstrated how Housing Maps (http://housingmaps.com) creates a visual display of current home rental opportunities in various Bay Area locations. Other examples demonstrated were the LibraryLookup Project by John Ludel (http://weblog.infoworld.com/udell/LibraryLookup) and Geotagging in Flickr (http://flickr.com) using Google Maps. Additionally, Raymond explained how to create a mashup using Yahoo Pipes (http://pipes.yahoo.com/pipes). His example used the *New York Times* World Section and Google Maps. Google Maps is a popular mashup visual resource. In fact, Google embraced this trend and released an API (application programming interface) that formalizes how people can use Google Maps for all sorts of mashups. In the afternoon, attendees immersed themselves into even more examples and demonstrations of mashup technology. Jill Tinsley, a recent MLIS graduate from the University of Arizona, provided a survey of visual searching resources, including oSkope Visual Search, Aquabrowser, WebBrain, Tafiti, Viewzi, and SearchMe, to name a few. This year's Cool Tools! demonstrations included three exciting tools that utilized mashups and web 2.0 technologies. Virtual Shelf was demonstrated by UC Berkeley School of Information 2nd year Masters students Devin Blong & Jonathan Breitbart. This student project created for the Open Library Project of Internet Archive allows users to visually explore online print collections. Harrison Dekker, Data Services Librarian at UC Berkeley's Doe/Moffitt Library, got playful with Google's versatile visualization tools for numeric data available in their web-based spreadsheet application (http://spreadsheets.google.com). And Laura Moody, Music Librarian and CARL member from San Francisco State University, provided a tour of LibGuides, a new tool from Springshare that helps libraries use web 2.0 technology to organize and distribute subject and research guide resources (http://libguides.sfsu.edu).

And if that wasn't enough of a visual and informative feast, the day was capped off with an introduction and tour of the Harrington Learning Commons, Sobrato Technology Center and Orradre Library. SCU University Librarian Liz Salzer, our workshop host, described the opening of their new facility, and tour guides offered attendees a glimpse of the building, which includes their Automatic Retrieval System (ARS), reconfigurable collaborative spaces, casual lounge seating, video editing suites, educational experimentation rooms, a café, and much more. Legislative Report

This being my first Legislative Report in the CARL Newsletter, I want to thank Aline Soules for all her guidance and support during my orientation period. She has been an expert guide in grooming me as your current Legislative Liaison. I greatly appreciate her help during this learning period.

What is mostly on everyone's mind is, of course, the state budget. As of this writing, no budget has been enacted. Although the budget is in the news almost daily, and the halls of the Capitol are filled with activity, most of the process goes on behind closed doors. Our budget has been passed on time only four times in the past 20 years. Technically, the budget is supposed to be passed beginning July 1 of each year, but passage has historically been delayed as late as September. Hopefully, by the time you read this newsletter, the state will have a budget. Once the budget is official, you can view details of its passage at the "2008-09 California Budget" website http://www.ebudget.ca.gov/. Look for Enacted Budget: Summary, Detail (currently a link awaiting activation!).

Over the next several newsletters, one of my goals is to take all of you along for a "ride" - the same route that I have traveled over this past year in learning about, and understanding the uses of, several websites that enable one to find the status of state and federal pending bills, the full text of pending legislation, legislative issues affecting libraries, voting records of our elected officials, federal legislative information from the Library of Congress, and a resource on California laws that relate to libraries. These sites are known as:

- Resources on Legislative Issues That Affect Libraries (Sprague Library, Montclair State University)
- * GovTrack.us
- * Thomas
- California Library Laws 2008

It is easy enough to Google a bill's name or number, a legislator's name, or quick search on how to write an elected official, but I am hoping some of you may find useful a more in-depth understanding and value of some of the websites I've hinted at above. Many of you may have quickly used these websites in the past to do a quick and dirty search, but as I explored these sites more thoroughly, I began to realize the wealth of information they contain.

I will, of course, also include in the newsletter information on current legislation. As you read future newsletters, contact me if you have questions, suggestions, or requests.

In Memoriam: Alan Paul Stein (1947-2008)

Alan Paul Stein, library liaison to the College of Business and Economics at California State University, Los Angeles, died Sunday, May 25, 2008, at his home in Arcadia, California, after a multi-year battle with cancer. Alan was very active at CSULA, as well as in the larger academic community, and he will be sorely missed by his many friends and colleagues.



He was born on June 16, 1947, in Omaha, Nebraska, and moved with his younger brother and parents to El Paso, Texas, when he was 5. Growing up in Texas, like all proper Texans, he rode horses and wore boots. (Many will remember that he carried these practices into his later life in and around CSULA.)

Alan's extensive academic training garnered him a lengthy string of letters after his name. He received a B. A. in international relations (1969) from the University of Denver, and immediately thereupon, a Bachelor's in International Management from the American Graduate School of International Management (Thunderbird) in 1970. Also in this period, he spent some time as a library assistant in the El Paso Public Library (in the summers) and at the University of Denver Library.

Librarianship seemed to be in his blood. Not content with his previous levels of academic preparation, Alan pursued and received his M.A. in Library Science at the University of Denver (1971).

His first library position was as a social sciences reference librarian and bibliographer at the University of Arizona (Tucson). While there, he obtained yet another degree, a Masters in Public Administration (1977), adding even more letters to his name.

In 1977, CSULA was perceptive (and lucky) enough to hire Alan, where he worked until May, 2008. During all these 31 years, he supported a number of programs and their faculty and students across campus, with primary concentration on supporting members of the School/College of Business and Economics. In yet another move to add even more letters after his name, in 1982, Alan received the Juris Doctor degree from the Glendale College of Law.

In the CSULA Library, Alan held several positions, starting as social sciences reference librarian and then, for several years, adding humanities. He coordinated and was head of reference services for some additional years as well. Alan was instrumental in developing the "library instruction" program at CSULA, and was the coordinator of library and bibliographic instruction, also for a number of years.

On campus, he loved working with individuals at all levels, for example, students in the CSULA Early Entrance Program (for gifted children); high school students in the campus service area; visiting faculty and administrators from Egypt through Fulbright exchanges in the area of English as a Second Language / English as a foreign Language (ESL/EFL); and officers of various Japanese international trade organizations and corporations, as well as government representatives. Also on the international scene, he delivered seminars on information literacy for the U. S.

Information Agency in Austria, and consulted with library and educational organizations in Argentina.

Argentina played an even bigger role than being just a place in which Alan could consult, for it was there that he married Lia Kamhi-Stein. Lia had come to the CSULA campus as an intern in the Career Planning and Placement Office in the summer of 1988. When she returned to her native Argentina, Alan began logging many airline miles and phone calls.

In December, 1989, Alan and Lia were married in the Civil Registry in Argentina, followed by their religious ceremony in January, 1990, the year in which Lia came to live in the U. S. Hannah Malena Stein, the joy of Alan's and Lia's life, was born in May, 2006. From the moment she was born, they knew she was going to speak English and Spanish, the languages they spoke. One of Alan's last wishes was to celebrate Hannah's birthday on Sunday, May 18, 2008, even though he was in failing health. With the help of friends, Alan's wish came true.

Alan won a number of "Innovative Instruction Awards" over the years, all in the context of developing instruction programs in a wide variety of disciplines. In addition to supporting programs in the area of business, he also concentrated his instructional and research efforts in the ESL/EFL areas. He became heavily involved in the California Association of Teachers of English to Speakers of Other Languages (CATESOL). He also participated in the international organization, TESOL (Teachers of English to Speakers of Other Languages). In addition to his heavy involvement as a presenter at TESOL and CATESOL conferences, Alan was heavily involved in the organization of CATESOL conferences. He presented or co-presented numerous times and published widely in the field, including an award-winning paper on teaching information competency as a third language.

He was active professionally in library organizations, including the Southern California Online Users Group, Special Libraries Association, California Academic and Research Libraries, and Academic Business Librarians Exchange, of which he was chair twice. Alan served on a variety of campus committees as well, and was representing CSULA on the CSU Systemwide Electronic Access to Information Resources Committee (EAR) at the time of his death.

Alan Paul Stein will be remembered for his kindness and his sincere interest in people; his strong desire to help and mentor students; his complete engagement as a dedicated educator, always striving to improve his and others' pedagogical practices, leading to greater student successes; and his strong sense of ethics and his genuine collegiality.

Alan is survived by his wife, Lia Kamhi-Stein; his daughter, Hannah Malena Stein; his parents, Charles B. Stein and Betty Stein; and his brother, Steve Stein.

CSU Northridge

Orange Coast College

The new Orange Coast College Library opened Thursday, January 3, 2008. The official opening party was on February 5, 2008. The two-story, 88,777-square foot building includes a 128,000 volume book and media collection; large and small group study rooms; two classrooms, one with computers; a computer lab; a media center; and a Friends of the Library book store. The library moved in fall 2000 from a four-story building which is now called Watson Hall and includes counseling, financial aid, and other student services. After seven and a half years in a temporary facility away from the main part of campus, the library's move to the west side of the campus has made it a focus point again. Attendance has greatly increased at the reference desk, for instruction, and in use of the library to study or just relax between classes. The building is both aesthetically appealing and also very functional, according to the library's dean, Sheri Sterner, and the librarians and library staff.
